ELD Update

COMPLETE THE FOUNDATIONS FOR LEARNING TRAINING BEFORE END OF YEAR

The required training called "Foundations for Learning" is available to early care and education (ECE) providers. This free, two-hour training on child development is available on the "Learning with OCCD" website in English, Spanish, Russian, Vietnamese, and Traditional Chinese. The deadline to complete this course is December 31, 2022. To access this training, visit **occd.educadium.com**

UPDATED COVID-19 GUIDANCE NOW AVAILABLE

As Oregon continues to focus on COVID-19 prevention, ELD and the Oregon Health Authority (OHA), has updated Oregon's Child Care Provider COVID-19 Requirements and Recommendations, effective Nov. 9, 2022.

Some key updates to COVID-19 guidance include:

Removal of requirement to quarantine if exposed and not symptomatic. Providers are still required to exclude any child or staff who has COVID-19, regardless of vaccination status. Removal of requirement to notify Local Public Health Authority (LPHA) for every COVID-19 case. Instead, providers will be required to report elevated levels of absenteeism due to respiratory illness.

Added recommendation: When returning to care after isolation, individuals 2 years and older

should wear a mask for an additional five days. Individuals who cannot or do not wear a mask should continue to be excluded for an additional five days, for a total of 10 days.


COMING JANUARY 2023! A webinar video series on the new school-age rules.

First Children's Finance (FCF) is partnering with ELD to offer training opportunities for ECE providers to support financial management and grant reporting. During this two-hour training, family providers will learn basic tools to separate personal and business finances. Rating Renewal Updates

Spark has some exciting new options for renewing your star rating certificate!

Initial star ratings last for 3 years and can be extended in one-year increments. Previously, programs could extend their certificate by completing a Spark Program Update Report (SPUR). After determining that the SPUR did not did not fully capture all of the activities that programs were engaged in to maintain the level of quality represented by their Spark rating, it was decided to create a more robust and meaningful process.

Programs now have 5 options to share their continuous quality improvement efforts and extend their Spark certificate for one year. These options allow programs to choose which activities are most relevant and share the outcome of their efforts.

<u>Option 1 – Complete a Spark Renewal Portfolio</u>

The Spark Rating Renewal Portfolio consists of 9 Spark standards. The Renewal Portfolio can be submitted electronically, or printed and sent in via email or postal mail.

Option 2 – Resubmit your Spark Portfolio for a higher star rating

Have you been thinking about resubmitting your portfolio for a higher star rating? This is a great time to do it and we are happy to help. Reach out for the most current version of the Spark portfolio, and your previous Summary Score Sheet, if needed.

Option 3 – Request an on-site observation

Invite a member of the Spark Assessment team to do an on-site observation with your program. The assessor will use either the CLASS (Classroom Assessment Scoring System) or the ERS (Environment Rating Scale) tool to evaluate your program environment and interactions. A detailed summary will be shared with you, highlighting strengths and offering opportunities for growth.

<u> Option 4 – Participate in collaborative CQI efforts</u>

Are you currently part of a Focused Child Care Network, or working with a coach or mentor? If so, you can share your experiences, goals and continuous quality improvement efforts to renew your Spark certificate.

Option 5 – Participate in professional development activities related to Spark Standards

Professional development is a great way to ensure that your program environment, policies, and practices are aligned with the Spark standards. You can renew your Spark certificate by sharing the activities you and your staff have participated in during the past year and how you have implemented what you learned.

Is your Spark certificate due for renewal? You can begin this process by completing a SPUR, which can be found on our website, **here**. Scroll down to find the Spark Program Update Report which is available in Spanish, Russian, and English. On the form, click on box #2, *I would like an updated certificate showing my rating is current. (If your rating has expired, you may be emailed a Rating Renewal to complete before an updated certificate is sent.)* When we receive your SPUR, you will be sent the information and documents needed to select your renewal method and complete the process. You will also be sent a 3-month extension of your certificate to allow time to complete the process. If you need additional time, just let us know!

Reimbursement Money Available!

There are funds available that you may qualify for! You can be reimbursed for the cost of training, lead testing, and cost to meet ODHS health and safety guidelines. Below is a list of the reimbursements and requirements:

For License Exempt Providers Participating in DHS Subsidy:

1. Lead Testing Reimbursement: Reimburse the cost of lead testing and correction actions if required.

2. Safety & Quality Enhancement Reimbursement: Reimburse the cost of equipment or facility repairs to help comply with ODHS health and safety requirements.

3. Training Reimbursement: Reimburse the cost of attending trainings, workshops, conferences and/or taking college classes.

For Licensed Providers and Centers:

First Aid/CPR training: Reimbursement for *Aide 1* and *Assistant 1* Providers and *Licensed Family Child Care Providers* who completed First Aid/CPR training.
 Lead Testing Reimbursement: Reimburse the cost of lead testing.

To Apply:

We are excited to announce that there is a new easier way for providers to submit their payment requests through the new <u>Secure Portal</u>! This user and mobile-friendly site will allow for a faster and more secure submission of payment requests including stipends, reimbursements, Spark Supports, and Focused Child Care Network.

Providers and CCR&R staff will have direct access to download forms, fill them out electronically, and upload them to submit. All forms are available in English, Spanish, Russian, Mandarin, and Vietnamese.

ALL ABOUT Developmental Screening

What is developmental screening?

- Developmental screening is a short, easy-to-complete formal test of young children's developmental skills, such as motor, cognitive, language, and social-emotional skills.
- A developmental screener reliably distinguishes children who should be referred for further, more comprehensive assessment from those who don't need to be referred.¹
- Doctors, nurses, and other early childhood professionals use developmental screening to tell if children are on track with developing basic skills, or if they might have delays.²
- A developmental screening tool, such as ASQ®-3, is a research-based instrument that asks questions about a child's development and gathers information.³
- All children should receive developmental screenings.³

Why do we need developmental screening?

- Before the age of 18, about one in seven children in the United States will experience a developmental disability or a disabling behavioral problem.⁵
- Before the age of five, as many as one in four U.S. children are at risk for developmental delays or disabilities.⁴
- Fewer than 50% of these children are identified before starting school.⁵
- Identifying delays early and providing help before age five produces effects that significantly exceed those of services provided to school-age children.¹

Tip of the Month

Did you know....

There are a variety of materials you can add to your space to make it a more inclusive and trauma responsive environment?

When we provide structure and consistency in our environments, we are supporting all children regardless of age or ability. Here are a few ideas that may be helpful.

- **Timers:** these tools can help adults stick to the routine without constantly checking the clock. They are also a visual support for children to know when one activity ends and when a transition begins. Transitions should feel authentic, respectful, and natural. Access to timers, that can be regulated by children, aid in cooperative play too. Kitchen timers, small hour glasses, and visual timers like the Time Timer help children to see the passage of time, even if they cannot read a clock.

- **Placemats or trays:** using these tools at the table during meal or activity times helps children to define their own bubble and helps teachers have a clear way of redirecting children back to their own space.

- **Adjustable tables:** using these tools can provide an alternative to sitting for those children who could benefit from standing during meals or activity times.

- **Loop resistance bands:** these tools can be placed around chair legs to give busy feet something to do while sitting.

- **Flexible seating:** providing a variety of seating options can make a big difference. Consider adding armchairs, wobble stools, balance ball chairs, bumpy seats/cushions, Storytime Cushions, or ErgoErgo seats. Providing a diverse assortment of these tools offers children who want to move the option to move and children with anxiety an extra level of comfort.

20 HGD HDFS 247 01 Preschool Child Development - (3 Credit) Online

This course covers the principles of theory and development for children aged conception through eight years of age. Emphasis is placed on physical, intellectual, emotional, and social development of children, including a strong focus on brain development.
