



# SOUTHWESTERN

AN OREGON COMMUNITY COLLEGE

Southwestern Oregon Community College applied for and received the Higher Education Emergency Relief Funding (HEERF) under the CARES Act in the amount of \$540,845, from the Department of Education. These funds were used to provide emergency assistance to students in spring term 2019-2020. Southwestern's goal was to serve as many students as possible within federal guidelines.

1. On April 16, 2020, Southwestern Oregon Community College completed and submitted the Certification and Agreement online to request the emergency grant funding through the Coronavirus Aid Relief and Economic Security (CARES) Act.
2. On April 25, 2020, Southwestern received notification that our request for grant funds was approved. The approved grant amount for HEERF funds is \$540,845.
3. The estimated number of students eligible to receive funding under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive HEERF grants is 896. Updated to 898 June 23, 2020.
4. Funds disbursed to student accounts on June 8, 2020 and processed by the Business Office on June 9, 2020. A separate subsidiary was created, as to guarantee no HEERF funds inadvertently were used to cover any college accounts receivables. Funds were distributed directly to the students via EFT and check.
  - a. June 23, 2020 – found 2 more students determined eligible for funding
  - b. July 6, 2020 – disbursement made to those 2 additional students
5. Southwestern will be disbursing funds directly to students via direct deposit or check that meet the following requirements:
  - a. Title IV eligible and meet all basic eligibility requirements
  - b. In good standing for Satisfactory Academic Progress
  - c. Degree-seeking
  - d. Enrolled in on-campus courses winter term 2019-2020 and transitioned to all online classes spring term 2019-2020.

6. The number of students who met the criteria in #5 and received funding were 755. Updated to 757 June 23, 2020.
7. Southwestern awarded \$540,825 of the \$540,845.
  - a. As of July 6, 2020 - \$540,845 of HREEF funds spent
  - b. As of July 6, 2020 - \$1,330 institutional CARES grant funding
8. Southwestern determined that all students have been impacted by the transition to online courses. Students received funding based upon their enrollment status as of May 19, 2020. The following were determinations in supporting funding for all students:
  - a. All students impacted by move to all online.
  - b. Coos and Curry Counties are rural communities with subpar internet access and availability. The costs associated with obtaining or increasing internet access locally, are between \$240 - \$300 for three months.
  - c. Oregon K-12 shut down immediately and began a "Distance for All" program throughout the state.
  - d. Families sharing devices in the home. Many students had to purchase a phone, tablet, or laptop in order to complete homework and interact with the online learning management system at Southwestern.
  - e. Funding determined:
    - i. Full-time = \$775
    - ii. Three-quarter-time = \$675
    - iii. Half-time = \$575
    - iv. Less-than-half-time = \$475
9. Notification sent to students on June 9, 2020
